The following incident occurred in the City of Delray Beach, Palm Beach County, FL.
 On September 8th, 2020, I responded to Delray Medical Center, 5352 W Linton Blvd, in reference to a DUI investigation involving Bartolo Renteria (offender) (Crash #20-011947). When I observed Renteria enter the Emergency Room, Renteria had bloody and glassy eyes, was being verbally assaultive to medical staff, had the odor of an unknown alcoholic beverage, and had slurred speech.
 I observed that Renteria had redness and swelling on his left collarbone area which indicates a recent car crash injury from the driver's seatbelt. Renteria also had numerous fractured and dislocated ribs which correlates with the fact that his chest area struck a hard object (steering wheel/airbags) at the time of the accident. Renteria had the keys to his 2020 Dodge Charger (FL Tag CXSB48) clipped to his hip which was involved in the accident. Renteria is the registered owner of the Dodge. Lt. Rasor responded to the scene of the crash and advised me that the driver's seatbelt had been extended and was locked in a belted position of a person, which correlates with someone having the seatbelt on during the crash. It should be noted that Lt. Rasor is Traffic Homicide certified and worked in the Traffic Homicide Unit for five years. Renteria was extremely hostile toward Officers on scene to include Delray Beach Fire Rescue Personnel.
 Renteria repeated numerous times to me "what are you a 1-year cop or a 1/2-year cop" and then stating "I'm a five-year cop." Ofc. Addea was with me and asked Renteria about the crash. Once Ofc. Addea was done, I advised Renteria that I was doing a criminal investigation and read him his Miranda Rights. Post-Miranda, Renteria stated that he did not recall what accident I was talking about. Renteria then stated that he was actually outside of his vehicle during the crash. When I asked Renteria why he would be just standing on the side of S Military Trl as his vehicle drove by, Renteria stated he

actually parked his vehicle on S Military Trl. Renteria stated that he did not drink any alcohol prior to our discussion. Renteria then went on to start rambling about how his vehicle is a push to start. Renteria then stated, "do you have a wheel witness, then I'm not talking." Renteria had numerous mood swings as at one point he was crying after having a discussion with a command staff member. Renteria was read implied consent and was requested a sample of his blood to which he declined even after understanding the implications under implied consent.



During the 0404hrs on 09/09/20, Delray Beach Police Dispatch received a call from Renteria who wanted Delray Beach Officers to go by another Boca Raton Officer's house to let her know that he was at Delray Medical Center. On the phone call you can hear Renteria's slurred and mumbled speech. Renteria also makes a couple mistakes such as saying he was at Boca Regional when he was at DMC. The phone call was uploaded to Evidence.com.

Lt. Rasor conducted an inspection of the interior of the black Dodge Charger seat belt area and determined the following: The driver's seat belt was extended and locked. It had been utilized by the driver during the crash. The driver's seat belt was still buckled. The passenger seat belt was locked at the post and not extended. The passenger seat belt was not utilized during the crash. The vehicle had air bag deployment.

Officer Addea informed me the point of impact between the two vehicles had occurred at Fountains Way north of the final rest between the two vehicles. The point of impact to the final rest of the black Dodge Charger was 317 feet.

Lt. Rasor informed me of the following: Due to the heavy rain throughout the night and the distance from the crash point of impact and the final rest of the two vehicles. The black Dodge Charger was exceeding the speed limit of 45 MPH on the roadway prior to and up to the crash. The distance between two points and the angle of the crash would place the estimated speed of the black Dodge Charger between 60 MPH and 80 MPH above the speed limit of 45 MPH. Then factor in the heavy rain and wet road conditions, the black Dodge Charger driver Bartolo Renteria was the causation of the crash for too fast for conditions FSS 316.183(1) / FSS 316.183(4) (e).

Due to the above stated facts, I believe that Renteria was under the influence and in control of the vehicle during the crash. I believe that there is probable cause to charge Renteria with DUI w/ Property Damage per F.S.S. 316.193(3) (C) (1).
